Meeting of the Clayton County Board of Supervisors at 600 Gunder Road NE, Elkader, Iowa.

Keehner moved, Doepcke seconded to approve the minutes of the June 1, 2020 meeting. Ayes: Doepcke, Keehner and Peterson. Motion carried.

Doepcke moved, Keehner seconded to approve the claims as presented totaling \$234,374.43. Ayes: Doepcke, Keehner and Peterson. Motion carried.

Doepcke moved, Keehner seconded to accept and place on file the End of Fiscal Year 2019 Financial Statement of the First Judicial District Department of Correctional Services. Ayes: Doepcke, Keehner, Peterson. Motion carried.

Keehner moved, Doepcke seconded to authorize the chair to sign the FY2019 Cost Allocation Plan at the recommendation of Auditor Jennifer Garms and to place on file. Ayes: Doepcke, Keehner, Peterson. Motion carried.

Auditor Jennifer Garms made a recommendation to enter into a contract with Cost Advisory Services, Inc., for cost allocation services. Keehner moved, Doepcke seconded to authorize the chair to sign the contract with Cost Advisory Service, Inc., for cost allocation services for fiscal years 2020, 2021, and 2022. Ayes: Doepcke, Keehner, Peterson. Motion carried.

Bids were opened for a new 2020 Dodge Durango for the Sheriff's Office. The bids were: Torkelson Motors - \$30,550 and Brown's Elkader - \$30,500. Doepcke moved, Keehner seconded to authorize the purchase of a 2020 Dodge Durango from Brown's Elkader for \$30,500. Ayes: Doepcke, Keehner, Peterson. Motion carried.

Keehner moved, Peterson seconded to approve the non-union contracts for Secondary Roads employees. Ayes: Keehner, Peterson. Nays: Doepcke. Motion carried.
