Ordinance # 1-2011

An ordinance repealing Ordinance # 1-2001 and establishing election precincts in Clayton County, Iowa, as required by Sections 49.4 and 49.7(6) of the Code of Iowa.

WHEREAS, the census year of 2011 has now passed and re-precincting is required by state law,

WHEREAS, no changes from the currently established voting precincts are proposed or required,

WHEREAS, BE IT ORDAINED AND ENACTED by the Board of Supervisors of Clayton County, Iowa, that Ordinance # 1-2001 is repealed and Ordinance # 1-2011 is adopted with the following election precincts established in Clayton County, Iowa:

<u>Precinct Name:</u>	<u>Area Description:</u>
Boardman-Highland Precinct	Boardman and Highland Townships and the City of Elkader;
Buena Vista Precinct	Buena Vista Township and the City of North Buena Vista;
Cass Precinct	Cass Township and the City of Strawberry Point;
Clayton-Garnavillo Precinct	Clayton and Garnavillo Townships and the Cities of Clayton and Garnavillo;
Cox Creek-Sperry Precinct	Cox Creek and Sperry Townships and the City of Volga;
Elk-Mallory-Volga Precinct	Elk, Mallory and Volga Townships and the Cities of Elkport and Garber but excluding the City of Osterdock;
Farmersburg-Wagner Precinct	Farmersburg and Wagner Townships and the Cities of St. Olaf and Farmersburg
Giard-Monona Precinct	Giard and Monona Townships and the Cities of Luana and Monona;

Grand Meadow Precinct

Grand Meadow Township and the portion of the City of Postville in Clayton County;

Jefferson-Millville Precinct

Jefferson and Millville Townships and the Cities of Guttenberg, Millville and Osterdock;

Lodomillo Precinct

Lodomillo Township and the portion of the City of Edgewood in Clayton County;

Marion Precinct

Marion Township;

Mendon Precinct

Mendon Township and the Cities of Marquette and McGregor;

Read Precinct


Read Township

This ordinance shall be in effect on January 15, 2012, after its final passage, adoption and publication as provided by law.

Notice of public hearings were published on November 9th and 16th, 2011, in the Clayton County Register, Guttenberg Press and the Outlook. The public hearings were held on November 14th and 23rd, 2011. This ordinance was adopted on November 23, 2011, after the second public hearing with the third hearing waived by motion of the Clayton County Board of Supervisors. This ordinance was published in the November 30, 2011, issue of the same newspapers.
