#### PROCEDURES TO RESOLVE FENCE DISPUTES

Chapter 359A of the Iowa Code governs fence disputes. When reviewing the sections in this chapter, be sure to check fir legislative amendments. A number of Iowa Supreme Court cases have also shaped the Iowa law on fences.

- 1. Complaining party makes a written request to non-compliant landowner. Complaint should be served by the County Sheriff's Office. (*Form FV-1*)
- 2. If the non-compliant landowner does not erect or maintain the fence in thirty (30) days, the complaining party makes a written request to the Township Trustees. (Form FV-2) Township should collect Fence Viewer fee at this time.
- 3. Fence Viewers give a minimum of five (5) days written notice to the other party or parties of the time and place of hearing. (Form FV-3) The Township Clerk completes the form. It is suggested that the notice be served by the County Sheriff's Office unless the parties accept service.
- 4. Fence viewers make decision and set a time for to be completed. (Form FV-4)
  - Include a legal description of the fence location
  - Specify the kind of repairs each landowner is to make
  - Assign a dollar value of repairs and completion date to each party
- 5. Work is done by landowners.
- 6. If work is not done within thirty (30) days as ordered...
  - Complaining party must deposit with Fence Viewers a sum of money sufficient to pay for the work needed to be done.
  - Fence Viewers proceed to have work done.
  - The non-compliant landowner is billed for the costs.
  - If the owner with the duty to pay fails to do so within ten (10) days ...
    - Fence Viewers shall certify to the County Auditor the full amount due, including Fence Viewers' fee (Form FV-5)
    - The amount is collected as real property taxes.
    - Complaining landowner is repaid when taxes are collected.
- 7. Fence Viewers' decisions may be appealed to the District Court within twenty (20) days of the decision.

The County Attorney should be consulted with respect to the procedures and the law involves in fence viewing. (Note that Section 359.18 of the Iowa Code does not require County Attorneys in counties with populations greater than 25,000 to provide legal assistance to townships.) The Township Clerk and Trustees should be familiar enough with the procedures and forms to handle the bulk of the problems encountered.
